If not, PR or Employment pass stamp must be reflected on the passport ➢ Return air ticket / hotel booking ➢ Applicants holding a new passport are required to submit old one. ➢ Original Official Notification of Issuance of Visa from the authorized department. Tourist Visa (L-visa)	<ul style="list-style-type: none"> ▪ The requirements are as follows: <ul style="list-style-type: none"> ➢ Original Passport with at least 6 months validity and a blank visa page ➢ Complete visa application form (download application form) ➢ Photocopied Employment pass/Work permit/PR NRIC. If not, PR or Employment pass stamp must be reflected on the passport ➢ Return air ticket / hotel booking ➢ Applicants going to visit family members should submit the certificate of family relationship ➢ Applicants holding a new passport are required to submit old one. 			
Remarks	<ul style="list-style-type: none"> ▪ Visa is not required for Japan & Brunei passports holders if they stay less than 15 days for visiting relatives or friends, doing business and tourism. ▪ Bangladesh and Sri Lanka passport holders have to apply their visa personally. Please provide additional documents: last 3 months Bank Statement, Flight itinerary, Hotel voucher and contact person in China. ▪ Indonesia passport holder with Employment pass/Work permit/PR NRIC will need to apply visa in Jakarta if they had not been to China before. ▪ WEF 17May 10, French passport holders will need to apply visa in person.
