Transit Visa	<ul style="list-style-type: none"> ▪ The requirements are as follows: <ul style="list-style-type: none"> ➢ Original Passport with at least 6 months validity ➢ Complete application form (downloaded transit visa form) ➢ Photocopied Employment pass / Work permit / PR NRIC ➢ Flight itinerary / Return air ticket 			
Remarks	<ul style="list-style-type: none"> ▪ Singapore passport holders do not need to apply for Sri Lanka visa up to 30 days of stay. ▪ For the list of countries permitted to enter Sri Lanka without visa up to 30 days of stay are stated in visa not required under schedule 'A' ▪ To enter Sri Lanka, a foreign national must have sufficient funds (currency / travellers cheques / credit card) for maintenance ▪ WEF 01Jan'12, all Holiday or Business travellers to Sri Lanka must have Electronic Travel Authorization (ETA) for entering in to Sri Lanka.
